

Comments can be made visible to the applicant by toggling on the Visible to Applicant option. Comments directed only to the IRB Administration should not be made visible to the applicant.

Comments that relate to items that require changes to be made can be flagged by toggling on the Change Request option. Items that require changes include conditions and queries. Suggestions should not be flagged as change requests.
